**2. HAZARDS IDENTIFICATION**

**EMERGENCY OVERVIEW**  
 DANGER. CORROSIVE. CAUSES SKIN AND EYE BURNS. HARMFUL OR FATAL IF SWALLOWED.

**Principal routes of exposure:** Eye contact. Skin contact. Inhalation. Ingestion.

**4. FIRST AID MEASURES**

**Eye contact:** Hold eye open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eyes. Get medical attention immediately.  
**Skin contact:** Take off contaminated clothing. Immediately flush with plenty of water for 15-20 minutes. Get medical attention immediately.  
**Inhalation:** If breathing is affected, remove to fresh air. If person is not breathing, call 911 or an ambulance and then give artificial respiration, preferably by mouth to mouth, if possible.

**Ingestion:** Call medical attendant, doctor, or poison control center immediately. Have person sip a glass of water if able to swallow. Do not induce vomiting unless told to do so by a poison control center or doctor. Never give anything by mouth to an unconscious person.
