## SECTION 2 HAZARDS IDENTIFICATION

**Classification:** This product is not classified as hazardous according to OSHA CFR 1910.1200 or EU Directive 1999/45/EC, as amended.

**Acute health effects**

**Skin contact:** Unlikely to cause skin irritation

## SECTION 4 FIRST AID MEASURES

### First Aid Procedures:

**Inhalation:** Move person to fresh air immediately. If breathing is difficult, consult a physician.

## Section 5 FIRE FIGHTING MEASURES

<b>Hazardous combustion products:</b>	Carbon monoxide and carbon dioxide.
<b>Extinguishing Media:</b>	Water, dry chemical, carbon dioxide or foam.

## SECTION 6 ACCIDENTAL RELEASE MEASURES

### Spill / Leak Procedures:

Sweep up or vacuum spilled toner and carefully transfer into sealable waste container. Sweep slowly to minimize generation of dust during clean up. If vacuum is used, the motor must be rated as dust tight. A conductive hose bonded to the machine should be used to reduce static build up (See Section V). Residue can be removed with soap and cold water. Garments may be washed or dry-cleaned, after removal of loose toner.

### Environmental precautions:

Do not flush into surface water or sanitary sewer systems. Dispose of waste material in accordance with local, state, and/or federal regulations.

## SECTION 7 HANDLING AND STORAGE

**Handling:** Keep containers closed when not in use. Handle and open containers with care. Use with adequate ventilation. Avoid inhalation of dust and contact with skin and eyes. Keep away from sources of heat, sparks, and open flames.

**Storage Requirements:** Store at room temperature in the original container. Keep the container tightly closed and dry. Do not store with strong oxidizers.
