Carbon black in this preparation, due to its bound form, does not present this carcinogenic risk. Carbon black is present only in a bound form in this preparation. None of the other ingredients in this preparation are classified as carcinogens according to ACGIH, EU, IARC, MAK, NTP or OSHA.
