### Section 4. First aid measures

#### Description of necessary first aid measures

**Eye contact** : If material comes in contact with the eyes, immediately wash the eyes with large amounts of water for 15 minutes, occasionally lifting the lower and upper lids. Get medical attention.

### Precautions for safe handling
