If ethanol is used, a therapeutically effective blood concentration in the range of 100 - 150 mg/dl may be achieved by a rapid loading dose followed by a continuous intravenous infusion. Consult standard literature for details of treatment. 4-Methyl pyrazole (Antizol TM) is an effective blocker of alcohol dehydrogenase and should be used in the treatment of ethylene glycol, di- or triethylene glycol, ethylene glycol butyl ether, or methanol intoxication if available. Fomepizol protocol (Brent, J. et al, New England Journal of Medicine, Feb 8, 2001, 344:6, p. 424-9): loading dose 15 mg/kg intravenously, follow by bolus dose of 10 mg/kg every 12 hours; after 48 hours, increase bolus dose to 15 mg/kg every 12 hours. Continue fomepizol until serum methanol, EG, DEG, or TEG are undetectable. Persons receiving significant exposure should be observed 24-48 hours for signs of respiratory distress. Folates may be administered to enhance the metabolism of formaldehyde.
